Action: Organizations representing MSMEs, Trade &	President, KCC&I, vide his letter No. KCC&I/RA/15 dated April 2, 2009, has informed that advertisement has been issued in local newspaper and they have also issued circular to its members for the purpose. In response to the initiative lot of people have applied to banks for restructuring of their

To issue small advertisement in the media advising therein that the entrepreneurs who feel their accounts are likely to be under stress should approach their respective bank branches for the purpose of restructuring. Member banks were impressed upon to ensure submission of the data as per the prescribed time-bound programme to the SLBC for facilitating monthly meetings to review the position and monitor the implementation of the economic package in the State and also for ensuring onward submission of the progress reports to the Government of India for broad based review at the national level.

Review of restructuring of MSMEs Accounts at District Level:

Reserve Bank of India, vide letter bearing RPCD.JMU No.1103/03.01.24/2008-09 dated 24.02.2009 addressed

to all Lead District Managers in J&K State and a copy endorsed to Convenor, SLBC J&K, have advised that

ground level response to the initiatives taken by GoI / RBI with regard to re-scheduling / restructuring of

advances to MSMEs which have been affected by the global slowdown be reviewed in DCC/ DLRC meetings.

LDMs have been also advised to collect the requisite information from banks operating in their respective

districts in the prescribed format and place the same before ensuing DCC meetings.

Subsequently, Gol, Ministry of Finance, Department of Financial Services vide their letter bearing

F.No.21/5/2009-Dev dated 4th March 2009 (copy enclosed as **Annexure-C**) have advised that **SLBC Convenor**

Banks should undertake regular review of restructuring of MSMEs Accounts at the district level to be

carried out jointly by the DLOC Convenor and the General Manager of District Industries Centre (DIC). It has also been advised that SLBC Convenor will brief Secretary, Department of Industries of the State to

ensure proper coordination at district level, so that all eligible cases are restructured in time. The

information in this regard is to be communicated to Government of India by 30th of every month.

Accordingly, necessary instructions have been conveyed to all Lead District Managers/ BDSMs of Lead

districts in J&K State to obtain the requisite data from the banks operating in their respective districts on

monthly basis in the prescribed format and submit the same to office of the J&K SLBC by 15th of every month for enabling to send the consolidated data of all districts in J&K to GoI by 30th of every month as per the

directions of Gol. Besides, a brief in the matter has also been provided to the Commissioner/ Secretary to

Govt. of J&K, Industries & Commerce Department, vide letter No. LBD/Spl.SLBC/2009-620 dated 21st March

2009 with the request to ensure proper coordination at district level and issue necessary instructions to GMs

of all the DICs in the State.
